

The Music Licence (PPL PRS)

What is PPL PRS?

PPL (Phonographic Performance Limited) and PRS (Performing Rights Society) both licence the use of music and collect royalties, but they represent different rights holders. PRS represents the interests of songwriters, composers and music publishers and PPL represents the interests of record labels and performers.

East Ayrshire Leisure must record any instance where music is played within it venues and submit this to PPL PRS each year (June-May). We are then charged accordingly, therefore to cover this cost we pass this onto the group. As part of our recent pricing policy review for flexible spaces, which was implemented on the Ist July 2024, we have consulted with PPL PRS to ensure we are charging the correct fees. As a result the following charges will be applied from Ist October 2024.

If you can provide a valid digital copy of your PPL (PP222) licence via email along with your booking form there will be no charge. There is no exceptions for PRS, therefore this charge applies to each class.

Dance Schools (Practice / Lessons)

East Ayrshire Leisure Trust have made the decision that we will no longer accept bookings from dance schools unless they can provide us with a digital copy of their valid **PPL** (PP020) Licence. This applies to regular or one of bookings for the purposes of practice. There will therefore be no **PPL** charge for these sessions. There is no exceptions for **PRS**, therefore this charge applies to each class.
